Cancellations

A. Renter Cancellations or Reschedules

Associations are expected to pay all reserved dates that are confirmed in the reservation permit. If the reservation is cancelled for any reason, a cancellation fee of \$25.00 will be charged to cover administrative costs. No refunds are given 30 days prior to the rental. The City of Vadnais Heights may approve a game or practice reschedule if notice is received within 5 business days of the reschedule. *Fields may not be groomed for games if the city does not receive adequate notice of reservation changes.*

B. Weather Policy and Cancellations Issued by the City of Vadnais Heights

The City of Vadnais Heights reserves the right to close fields for use due to weather or other events that may cause damage to the turf. The city makes every effort to update our weather hotline at 651-204-6002 by 3:00 p.m. on the day of a cancellation, and to notify all users by email as soon as possible. There will be no refunds for inclement weather unless the reservation was cancelled by the City of Vadnais Heights; the City will provide users with make-up dates whenever possible. If a make-up date is not possible, a credit will be issued for a future reservation.
